Aim of the scholarship:

- ≈ preparing a paper with the length of 40 000 characters (with spaces and footnotes) at least that is expected to be published in a Hungarian legal journal in category “A” (exceptionally “B”);
- ≈ preparing a paper with the length of 20 000 characters (with spaces and footnotes) at least that is expected to be published in a foreign legal journal of as high quality as possible.

Maximum amount of money with one successful application:

- ≈ in case of publication in Hungarian legal journal: 40.000 HUF
- ≈ in case of publication in foreign legal journal: 80. 000 HUF

These sums of money are net incomes as scholarships for both full time and part time PhD students.

Total amount of money for this application: 1.500.000 HUF

Timeframe of application (realisation period):

20 April 2017 – 15 January 2018

Conditions of application:

- ≈ active status as full time or part time PhD student in the UD Géza Marton Doctoral School of Legal Studies;

Aim of the scholarship:

- ≈ funding the registration fee and/or costs of accommodation at a legal scientific (not PhD) conference in Hungary
- ≈ funding the registration fee and/or costs of accommodation and/or travel at a legal scientific conference abroad

Maximum amount of money with one successful application (costs have to be certified by invoices):

- ≈ in case of conference in Hungary: 50.000 HUF
- ≈ in case of conference abroad: 150. 000 HUF

These sums of money are net incomes as scholarships for both full time and part time PhD students.

Total amount of money for this application: 1.000.000 HUF

Maximum amount of money with one successful application (costs have to be certified by invoices):

- ≈ in case of translation of a paper with the length of 20 000 characters (with spaces and footnotes): 52.000 HUF
- ≈ in case of proofreading of a paper with the length of 20 000 characters (with spaces and footnotes): 26. 000 HUF

These sums of money are net incomes as scholarships for both full time and part time PhD students.

Total amount of money for this application: 1.500.000 HUF
